Brevi Bus Introduced in Putnam County

The new Brevi Bus, which was engineered and built in Putnam County, Florida, was unveiled in October. U.S. Congressman John Mica joined residents, local leaders and state representatives for the first public presentation and roll out of the new transit vehicle designed to service rural communities and passengers with special-needs.

Brevi Bus is Putnam County Ride Solution's response to the passenger requirements of rural, community transportation. While dirt roads demand a rugged vehicle, the human service transport requirements of community transportation require a short, more maneuverable vehicle that is able to access passenger's driveways for pick up and drop off. The coordination of relatively long, human service trips in rural counties also requires a high capacity vehicle capable of carrying at least 20 passengers in order to minimize passenger trip costs. Funding available to rural transit for capital replacement necessitates a long life vehicle. Many Ride Solution vehicles have been in operation for over 20 years. The Brevi Bus is the result of Ride Solution's desire for a rugged, smaller, high capacity, long life vehicle.

In 2003, Putnam County pursued federal transit assistance to update their vehicle fleet, which contained 10 aging buses. Their last new bus purchase occurred in 1989 and some vehicles had more than 500,000 miles of use.

In 2005, Representative Mica was successful in securing federal support for the new Put-

nam Ride Solution buses. However, after an extensive search, Putnam County was unsuccessful in locating a vehicle that would meet its needs. More than 50 percent of the county roads were unpaved, so a large traditional bus would not meet local requirements.

As a result, the county made the decision at that time to pursue the development of a locally engineered vehicle. A special congressional waiver was needed and finally obtained in 2008 to allow for the research and development of this new vehicle. With local support, the low-floor Brevi Bus was designed to be shorter, more maneuverable, more rugged and more accessible to those with disabilities.

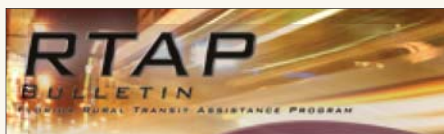

Florida Triple Crown Roadeo, April 15 - 16, 2011

Florida Highlights

On September 8, 2010, a successful Northeast Regional Mobility Summit was held in St. Augustine bringing together seven northeast counties to develop an action plan to further regional coordination. The summit's primary sponsor was the Jacksonville Transportation Authority and St. Johns Council on Aging Executive Director Cathy Brown hosted it. Nearly 200 people attended including members of the United States Congress, the Florida Legislature, locally elected officials, and state agencies, all the Community Transportation Coordinators in the area and many from other regions. its new transit facility. Putnam County introduced a new innovative vehicle for rural transit, the "Brevi Bus." Finally, in St. Lucie County, the Fort Pierce Redevelopment Agency, and the St. Lucie Council on Aging hosted the groundbreaking of its future intermodal transit facility.

Katie Arnold Named Mobility Manager for St. Johns County, Florida

The St. Johns County Council on Aging has appointed Katie Arnold as the mobility manager for St. Johns County. The program that Ms. Arnold will oversee is funded by a grant from the Florida Department of Transportation and is designed to assist residents of St. Johns County in two main areas pertaining to mobility:

- To encourage mobility independence in the senior population by promoting behind-the-wheel safety and competence.
- To develop and facilitate access to safe and cost-effective transportation alternatives for seniors who are not independently mobile. The mobility manager also serves as a resource for the transportation-disadvantaged population.

In Memoriam

In late 2010, Florida lost three advocates for Florida's coordinated transportation systems.

Shirley Conroy, TD Advocate, FACTS Executive Director, a former grants manager for FDOT, District 2, as well as one of the first coordinated transportation providers operating in Alachua County, died on November 19, 2010 in Jacksonville. Shirley was a tireless advocate for the Transportation Disadvantaged Program and coordinated transportation for over 31 years. At every turn in the road, she advocated and fought for Chapter 427, Florida Statutes, and the state statute requiring coordination. She was one of the early architects of the legislation and saw in it the possibilities of what coordination could be. She set out to see that the potential was made real. She was the genesis for the Northeast Florida Mobility Coalition, as she was the stewardship of District 2 Coordinated Transportation

when she was the FDOT liaison. It is not by accident that, today, northeast Florida is the most likely area to begin the regionalization of CTCs. She saw the potential in Community Transportation in a way that few have.

Mark "Leonard" Plotkin, died on October 20, 2010, in Tampa, Florida after an extended illness. Leonard was a tireless advocate for persons with disabilities in the Tampa Bay Area and in the state as a whole. Through his service on the Hillsborough County MPO's committees since 1994, he diligently worked to raise the consciousness on transportation-disadvantaged issues. In his capacity as a LCB member, he traveled each year to Tallahassee during the Legislative Session. In 2010, during TD Legislative Day, he met with over 33 legislators in the House and Senate regarding continuing to fund and to increase the Transportation Disadvantaged Trust Fund. Annually, he attended the Transportation Disadvantaged Training & Technology Conference to continue to update and sharpen his transportation knowledge, and to use that knowledge to improve transportation services for persons with disabilities. Leonard was known through our community for his wit, his plain speaking, his insight and his dependability.

Rita Kane, 57, of Miami, FL, passed away on October 14, 2010. Rita served as a TD Commissioner from 2002-2004. Her career in transportation began as Contract Manager for Comprehensive Paratransit Services in Miami. Ten years later, Rita moved to Orlando to serve as Vice President and General Manager of Gray Line of Orlando, and United Transportation, a company that provides broad transportation services to Orange, Osceola, and Seminole counties. Rita was passionate and outspoken about life. She was able to identify and speak the truth when others found it difficult. Her enthusiasm and dedication to hard work were hard to match.

Although we are sad to have lost these champions for coordination, their vision and passion for mobility will live on across Florida and our nation.
